Rules

- 1 Entrant provided Tents/Marquees/Stands – current Fire Legislation applies.
- 2 Gas cylinders – 2 (two) gas (propane) cylinders per unit (1 working plus 1 spare) with certificates.
- 3 Portable generators – diesel generators only are permitted within event arena – as directed by SFA official.
- 4 Fire breaks and emergency escape routes should be kept clear at all times.
- 5 No unnecessary movement of attendant vehicles should occur within the event fields. Attendant vehicles to be parked as directed by SFA.
- 6 No pets except on leash permitted within the event fields.
- 7 All vehicles should be insured, as necessary, to meet legal requirements.
- 8 All entrants shall comply with entry timing and specific requirements as advised/issued.
- 9 All exhibits shall remain on display until 4.00pm on the day of event.
- 10 Only one entry per form.
- 11 Fire Extinguisher and First Aid Kit to be provided by entrant for working exhibits.
- 12 If you do not have your entry ticket you will not get access to the display field.
- 13 Public Liability Insurance is required.
